

## **Notice: CHRB Medication Rule**

<u>Authorized (Controlled) Medications</u>: The CHRB has adopted the National Uniform Medication program for therapeutic medications. Those regulations can be found on the CHRB website (<a href="http://www.chrb.ca.gov/rules\_law.html">http://www.chrb.ca.gov/rules\_law.html</a> Rule #1844). The RMTC's recommended withdrawal times for controlled therapeutic medications can be found at <a href="http://rmtcnet.com/wp-content/uploads/2016/02/CTS-List-2-25-2016.pdf">http://rmtcnet.com/wp-content/uploads/2016/02/CTS-List-2-25-2016.pdf</a>.

If there are any questions, trainers are advised to consult their veterinarians on the use of all medications, CHRB official veterinarians Dr. Tim Grande, Dr. Will Farmer or Dr. Barrie Grant, or CHRB equine medical director Dr. Rick Arthur (626) 574-6351.

Any owner or trainer who directly or indirectly participates in the transport of a horse from Del Mar to either a slaughterhouse or an auction house engaged in selling horses for slaughter, shall be prohibited from any allotment or use of a stall or stalls at Del Mar, or other off-track stabling facility over which Del Mar exercises any control or indirectly funds.

Horsemen shipping to Del Mar are reminded of the five key requirements for running a horse at the track:

• Lasix/Official Bleeders' Certificate

California Workers' Compensation

• Current Coggins Test (12 month)

- Foal Certificate Papers
- California Owners' and Trainers' Licenses
