I. Approval of Minutes

On a motion by Mr. Aldrich, seconded by Mr. Lovingier, the minutes of December 6, 2019 were unanimously approved.

II. TOC January Newsletter – President's Report Mr. Avioli reviewed his President's Report, which will be part of the January newsletter.

III. Update on TOC- Vet Meeting 1-16-20

Mr. Avioli summarized the meeting held yesterday with four veterinarians and TOC representatives to begin a dialogue for working together. Subjects of discussion included the new fees for vet checks and the idea of a common medication dispensary.

 - A. Backstretch Safety Reform Update

Mr. Avioli reviewed the situation regarding escalating workers comp costs due to injuries and initiatives to implement safety measures through PostTime Insurance, which are being headed by Joe Hasson. Mr. Hasson then reviewed his memorandum outlining the WC Risk Reduction Project. A discussion ensued.

B. Ratify Increase in Participation Fees

Mr. Avioli reviewed the increase in Participation Purses and owners per start fees that were instituted as of January 1. The increase was approved by the Executive Committee in December. On a motion by Mr. Liewald, seconded by Ms. Siegel, the board unanimously ratified the Executive Committee's decision.

Mr. Avioli updated the board on last week's sports wagering hearing in Sacramento. A copy of the agenda for the hearing was provided to the board.
